- e. Customer balance of \$14,052.64.
  - Travis Can we post the names of the delinquent owners on the website.
    There was discussion about doing this. We would like to use this as a tool to engage the owners that are delinquent.
- f. Burn Pit is now open. We will pay a pro-rate of \$300.
- g. Frank Our annual expenses are roughly \$9,000 for general maintenance.

## 5. Committee Reports

- a. Architectural / Security Terry's Report
  - i. Campers 6 people have complied.
  - ii. The county needs a complaint before they will act on any violations.
  - iii. Terry has an updated list.
    - 1. There are 4 lots with shipping containers. Shipping containers are illegal unless you have a building permit.
    - Camper rules say you have to have a permitted driveway before they can put a camper on their lot. The driveway must have posted address.

- Terry will resign from the Architectural committee. This is a moot point; several houses being built without ever contacting Terry or Art.
- 4. Terry wants to know what information we want him to gather and provide.
- 5. The Pond at Elkhorn and Remington Someone needs to go down and look at it. It should be fixed.
- 6. Art He is getting about 3-4 phone calls each quarter from perspective owners and builders. Frank gets similar calls. Refer all these to Park County building department or developmental services. Art would like to get a statement about the driveway permit included with the building permit. So Art can help those that call asking about building and buying in Elkhorn.

#### b. Election

- ii. Art would like to resign as a board member but maintain an active roll in the boards activity.
- iii. Georgia and Frank need to be updated to 2020.
- iv. Art and Travis up for election in 2019.

- vi. No one knows anyone that would be interested in a board position.
