# Agenda - March 30, 2019 Annual Meeting - Minutes Indian Mountain Community Center 10:00 a.m.

#### 1. Open mic

- Gene from the Jefferson / Como fire protection district The dumpster at the fire station is not for public use. Please tell your owners that rent their houses to have their renters pack trash out.
- Forest service recommendations for clearing around houses, visit the Como/ Jefferson fire website... www.JCFPD.org
  - o Fire Mitigation survey is needed for new building, \$250 fee.
- Fire restrictions / burn bans are for entire district, the district can't be divided up by area.

#### 2. Consideration of Agenda

- Meeting called to order.
- Nothing added to the agenda, it was approved.

#### 3. Water Update

- Water agreement is working, Bar Star is doing the work they need to do.
- We have received multiple invoices and we are disputing one of them.
- Water background Our wells deplete Denver water. When there is a water call, Bar Star releases water on our behalf. We have agreed with Bar Star to an annual fee of \$5,500. Bar Star must document and report their maintenance. This will be evaluated after 5 years and re-negotiated. Water storage and augmentation does not have a direct effect on the wells. Every sub-division must have an augmentation plan in place. Elkhorn purchased our water rights in 1974. Georgia sent the annual well report to our water commissioner, Garver Brown.
- Dave reminded everyone that there are only household well permits in Elkhorn. There are no domestic permits or agriculture permits.
- If you purchased a property with a well, you need to ensure the name has changed on the well permit and the permit is in your name.

### 4. Treasurer Report – 2019 Budget

- Regular account \$8,439.23
- Water account \$2,745.92
- Frank sent out dues invoices March 15<sup>th</sup>. He sent 113 by regular mail and the remainder by email.

- Dues are due on June 1.
- We have had 7 turnovers year to date.
- There is a glitch in the computer program that lead to an error in the budget.
- There will not be dues increase this year. If there are increases owners will be notified ahead of the increase.
- The budget was approved as presented.

## 5. Election update / Board Members for 2019

- We need board members; we elect 2 positions every year.
- Travis Stuckey will be stepping down
- Rick Schaegel will be joining the board.
- Since there was one person stepping down and one person interested in being on the board, so there are no elections for this year.

### 6. Fire Mitigation – Burn Pit

- John Thompson is holding a seminar on wildfire community preparedness, May 4th.
  - o Firewise program want to work on evacuation plan for the community.
  - $\circ$  9-12 training session, 11:30 1:00 lunch, 1:00 4:00 will be work session on the evacuation plan.
- EROA pays an annual fee to Indian Mountain to allow owners to use the burn pit.
  - We will discuss with Indian Mountain and communicate with our owners when the burn pit is open.

#### 7. Annual Picnic

- Annual Picnic is at 11:30 on July 6th; there will be a board meeting prior to the picnic.
- Board provides hamburgers and hot dogs; owners need to bring a side or dessert to share.
