Approval of Minutes

Secretary Gharst did not have copies of meeting minutes on hand to present. In summary, the meeting minutes of the regular meeting on April 12, 2008; the special meeting on June 21, 2008 and the annual meeting on July 5, 2008 were provided to members at the picnic and included in the newsletters. OLD BUSINESS

Save Our South Park Water

Bob Bridgewater advised the Board that SOSW08 is now a legally registered non-profit with the State of Colorado. This group previously solicited funds to support opposition to in-situ mining in South Park. Due to little activity on this topic recently, the Board agreed that there was not an urgent need to donate any money for this. Instead, the Board requested that Bob should find out more information about the organization, its mission, etc.

Water Court

Due to history with water issues in Indian Mountain Subdivision, the Board agreed it was prudent to review activities in the EROA area at Water Court in Greeley. Lee Phillips recommended Dan Brown, a water attorney who can provide this review on a regular basis on behalf of EROA. The cost is \$50/month; there might be a slightly higher cost in the first month for set-up processes.

Mike Flower moved to give Bob Bridgewater authority to negotiate the review at \$50/month (including up front costs and quarterly reporting to EROA). The motion was seconded and passed unanimously.


For the security patrol, Terry has reported that there have been some break-ins on Kite Court.

Social Committee

Ann Bridgewater reported that the attendance at the annual meeting/picnic was about ½ of last year's attendance. She advised that the reason included gas prices, probably, and the fact that the newsletter was not sent prior to the picnic. The Members Picnic held in September was very well attended. Ann suggested calling the picnic something else because some members were confused between it and the annual picnic. One suggestion was "The End of Summer Picnic". Newsletter

Mike reported that the upcoming newsletter would be ready to go as early as the following week, if the minutes for this meeting get submitted to him quickly. There was discussion about political cartoons, which might be offensive to individuals. Those types of cartoons will not be used again in the newsletter. Discussion then followed about whether or not a newsletter is needed or reducing the number of newsletters each year, whether advertisements have been valuable for the newsletter, the website, and content; but still being able to provide election information and other EROA business in a timely to all members. Any changes would have to consider advertisers through the year-end.

Debby Van Gundy moved to change the newsletter production to only 2 per year, spring and fall with the details to be worked out, allowing business card size print ads. The motion was seconded and passed unanimously.

NEW BUSINESS

There were no changes in the Board positions. The dates for the regular meetings will be posted on the website. Board voted to accept two grills from Paul Hlad. They will be stored in the shed but not put out without another vote. "Leash Law Enforced" will be added to main sign at Remington and Elkhorn Rd when new sign is made. The word "Annual" should not be used for the fall picnic potluck. A strongly worded article to be in the newsletter for owners to abide by the leash law when their pets are off of their property. With no further business to come before the Board, the meeting was adjourned.

TORNADO HITS PARK COUNTY MINOR INJURIES REPORTED

Minor injuries were reported after the first **tornado** in Park County recorded history spun through Eleven Mile State Park in southeastern Park County on Saturday at around 2:15 p.m.

Park County Undersheriff Monte Gore said the tornado went over Eleven Mile Reservoir, formed a water spout, and ran ashore near Witcher's Cove, where it picked up one camping trailer and threw it on its roof.

"This thing was pretty powerful as far as the damage," he said.

He said the worst injury was a laceration on a woman's arm.

"We were very, very fortunate," he said.

Kyle Fredin, a meteorologist with the National Weather Service office in Boulder, said the twister formed five to six miles east of Eleven Mile Reservoir and officially touched down on the northeast corner of the reservoir.

He said the Weather Service didn't have any estimates of wind speed.

EXCERPTS FROM A RECENT LETTER

Experiencing the Park County Tornado

Recently, my brother-in law and his friends from Southern California used my Elkhorn cabin as a base for their semi-annual fly fishing, male bonding trip. On this visit, they got more than they bargained for. Since my brother-in-law Greg is such an elegant writer, I thought you might enjoy this excerpt from the e-mail letter he sent me after his departure.

“And lastly, but certainly not least or to be forgotten in this missive, **THE TORNADO!!!** that hit South Park and 11 Mile Reservoir Saturday, August 23rd. As we later found out, it was the first reported, authenticated tornado **ever** in Park County. And Ron and I just happened to be there on the South Platte River when the whole surreal event took place, exactly in the middle of the River between the two Reservoirs.

“There was, of course, a massive super cell hanging overhead. But nothing particularly out of the ordinary experience one runs into out there during the day. However, as we were being driven off the river by high winds, pelting rains and electricity, Ron says “Hey Greg look up, there’s a tornado in the sky.” Sure enough, I look straight up and darn if there wasn’t that stark and unmistakable formation of gray ice cream cone descending from the black cloud. With a 360 degree doughnut trench surrounding the base of the cloud cone dagger, feelings of amazement, wonder, and what the hell do we do now - rush the brainpan.

“Mouths now fully agape, eyes the size of pancakes, we watched as it went through various growth and connection-to-ground scenarios. And realized - that we were really close to this beast. From where we were on the river I thought for sure the cars were in jeopardy in the parking area about 1/2 mile away. Just a matter of time before there goes all my goods. As people were fleeing to vehicles I got myself up on a nearby higher ground perch. Whereupon I could see this rather nicely formed tornado now on the surface of 11 Mile Reservoir, and picking up huge amounts of water. This spotting was good news for us because it put the thing now some miles from our location. Still, we beat feet to the vans as large pea-sized hail spanked us the whole way.

“We drive down to the Bridge parking lot to watch what was left of the tornado - now obviously dying. Finally disappearing completely. With rain and lightening still continuing all around we witnessed probably every emergency vehicle in the county and beyond racing to the South shore of 11 Mile. Where, before moving onto the lake, the tornado had apparently destroyed a campground site in the State Park. RVs tossed like straw, the whole destruction nine yards. So sez the newspaper accounts.

“Anyway, Ron and I decide this day is shot. At least for a period of time. So we go to Hartsel for a burger/beer and contemplation of what we just saw. As we park at the cafe with the locals all outside still looking toward 11 Mile, I notice a late model maroon-colored vehicle that looked strange, somewhat out of sorts. Actually a lot so. Except for the windshield, all the windows were gone. Blasted and smashed to bits with most of the glass displayed inside the car itself. A woman soon emerges from the cafe, and bleeding at the left arm above the elbow.

“Long story short. She and her boyfriend, while vacationing for the weekend at the campground hit by the tornado, had actually been forced to the car as the tornado suddenly descended upon them. The twister came so quickly they barely made the car. As they folded over each other on the front seat, the tornado destroyed the windows upon them. Some glass collected in a pile on the dash against the windshield at the passenger side corner. Along with dirt and weeds - all in the direction of the blasting swirl. The rest of the vehicle and contents were a trashed mess. What a ride that must have been. At least they didn't get overturned - or worse.

“Still panicked after it stopped for the moment (there was still observed threat), they had immediately bailed for Hartsel in search of relief and first aid. Which later resulted in the emergency workers at the campground desperately wondering where they and the car were - as there was record and knowledge of them camping there. Believe it or not I was part of the communication that made the rescue workers aware of where they were.

“Quite a show Mike and Sandra. Really. Another thank you in order? A tornado right on top of me while fishing the South Platte, and getting to watch this, I-can-now-die-having-seen-a-tornado, form/connect to ground. And wonder what happens next with us being on an open river savanna. After all I don't run like I used to. But at 9,000 feet altitude I guess it wouldn't have been so far a travel up to kiss the sky. Maybe I (the body) lands in the river? Or the reservoir? “
